Community Forums: 2024

Our belief in the power of community and commitment to listen and learn from all voices is served, in part, through our Community Forums. On hold throughout and briefly following the crisis of Covid-19, we have begun again.

On February 15, 2024, we held our first in the 2024 series, focused on our housing needs and the need for community solutions. An engaged and informative audience of about 50 people attended this event which held in the Nancy How Auditorium at the David. A Howe Library on a cold and windy night. Undeterred by the weather, attendees heard from individuals who courageously shared the traumatic journey they faced being unhoused when escaping domestic violence. The panel also featured service providers Belinda Knight, ACCORD Director of Community Operations and Rachel Trudell, Clinical Associate Executive Director/Clinical Counselor from Clarity Wellness who shared perspectives on the barriers faced by people escaping violence or struggling with mental health issues that impact access to safe housing. Current data on Allegany County's housing shortages was reviewed, highlighting the growing lack of affordable housing in our community.

Audience members also shared experiences, both as tenants and landlords. Discussion on tenant's rights and housing discrimination laws provided further perspective and education to all. Audience members helped to inform understanding of the community's needs by completing a survey. Most in attendance reported the event challenged their beliefs and assumptions and agreed that our community needs to take action to address our housing shortage.

The National Family Development Credential Program, now in its 25th year, is a prestigious nationwide professional credentialing program designed for frontline family workers. Through this program, direct service workers can acquire and practice empowerment skills necessary for delivering strength-based family support. To earn the FDC, a worker must complete 90 hours of interactive classroom instruction, prepare a skills portfolio with support from an individual portfolio advisor, and successfully pass a credentialing exam.



Giving Children and Families a Head Start How does Head Start support children and families?

Most people know that Head Start provides child care for children ages birth to 5 until they are able to enter Kindergarten, and the program does so much more. The Head Start program helps to prepare children developmentally for successful entry into school. Our Teachers and staff prepare and implement individualized lesson plans for children, assess their learning and development every three months, and screen for hearing, visual, cognitive, and social emotional concerns. We also work with parents to identify their needs and unique goals, supporting families along the path to a better tomorrow. Some parents set goals to go back to school, get a higher paying job, buy a house, or to reduce their stress. Our staff are there to support families with referrals, encouragement, and ongoing follow up and support. Our home based option provides educational and family support services right in families' homes.

The program aims to have 90% of enrolled children meeting or exceeding developmental expectations by the end of the program year. We have already exceeded this goal this year! 93% of children ages three to five are already meeting or exceeding developmental expectations in all six learning domains: social emotional, physical, language, cognitive, literacy, and mathematics. 99% of infants and toddlers are meeting or exceeding developmental expectations in the social emotional, physical, language, and cognitive domains, and 96% are meeting or exceeding developmental expectations in literacy and mathematics. Program staff and the Education Specialist support families in the referral and evaluation process for Early Intervention or Committees for Preschool Special Education when there are concerns about a child's development. Many children receive specialized services, like speech therapy, giving them the additional head start needed for success in school and in life.

Head Start has immediate center based openings for children ages 6 weeks to 5 years in Friendship, Wellsville, Cuba, and Bolivar. Over \$43 Million Boost for Local Child Care:

NYS Office of Children and Family Services Allocates Funds in Our Region

In a significant move to bolster child care services across Allegany, Cattaraugus, and Wyoming counties, the New York State Office of Children and Family Services (NYS OCFS) has allocated substantial funding to support various aspects of child care provision.

The funding breakdown reveals a strategic allocation aimed at addressing different challenges faced by child care providers:

- Stabilization 1.0: Provided financial relief to childcare programs to help offset unexpected business costs associated with the COVID-19 pandemic and stabilize program operations.
- Stabilization Workforce Supports (2.0): Aimed at existing licensed and registered providers to assist with recruitment and retention of staff.
- **Deserts RFA 1**: Encouraged people in the community to open new child care programs in areas with low to no child care options.
- **Deserts RFA 2:** For licensed and registered child care programs already in operation.
 - Component A: Allowed Day Care Centers and School Aged programs to expand their childcare slots.
 - Component B: Assisted home-based Family and Group Family child care programs to offer non-traditional hours.
- Workforce Retention Grant: Targeted at licensed and registered Child Care Programs to assist with recruiting and retaining staff.

The Child Care Assistance Program (CCAP) may be available for many families requiring childcare for work, job searches, employment training, education programs, and meeting income criteria.





Supporting Infant and Toddler Mental Health:

A Vital Resource for Child Care Providers



Mental Health has become a common phrase used frequently in the world today. As child development has continuously been studied and better understood, researchers are realizing that a person's mental health is impacted early on in their life as a baby and even as early as the perinatal period. With the New York State implementation of the statewide infant toddler mental health program, Child Care Services has been able to help inform childcare providers of the impact of infant and toddlers mental health and themselves as caretakers.

Our services focus on child care providers who offer care for children 0-35 months and is a resource to support the adults in the child care programs in making changes to benefit the classroom or program. It helps to improve children's social emotional functioning, reduces challenging behaviors, and decreases the prevalence of suspension and expulsion of BIPOC (Black Indigenous People of Color) children.

From Homeless to Housed: A Success Story from ACCORD's Housing Program

In May 2023, ACCORD's Housing Program received an application from an individual who indicated they were homeless with no income. The person was staying in Temporary Housing and needed assistance getting back on their feet. Within 30-days of applying, they found a suitable unit, submitted all required documents, and signed a lease. By early June, the client had moved into their own apartment, was approved for public assistance, and was on the hunt for a job.

After five months on the Rapid Re-Housing program, the person was able to secure full-time employment and increased their income to the point they could support the apartment without assistance.

Survivors contact our program for many reasons, including advocacy, support, information, referrals, and resource assistance. Our program, through New York State Flexible Funding, has assisted many survivors to reach greater personal, social, and economic stability through increased safety and security while decreasing stress and anxiety for themselves and their families.

ACCORD Increases Access to Food to Meet Community Need: Hosts Monthly Foodlink Pop-Up Pantries Throughout Allegany County

Twice a month, in several towns throughout Allegany County, you may see some familiar signs, "Food Distribution Ahead," and "Must Be Pre-registered." ACCORD's Pop-up Pantries have distributed to our neighbors 23,534 boxes of food since 2020.

Community food distributions were developed years ago and the model for distribution was adapted in 2020 over consideration for public safety during the COVID-19 pandemic. The drive-through distribution model was appreciated by recipients and host sites therefore many hosts sites like ACCORD decided to keep the drive-through model.

Distributions are planned in 6-month intervals, January-June and July-December. This allows the program ample time to outreach to the community and help interested families navigate the online registration process. Foodlink delivers 10-12 pallets of food, and a team of 8-14 volunteers load food into cars from each side of the pallets. In 2023, Foodlink delivered 652,613 pounds of food to Allegany County. ACCORD distributed 370,494 pounds, of which 87,514 pounds were from Pop-up Pantries.

The 2022-2024 ACCORD Community Needs Assessment revealed the top three needs reported by community members were food, health care and financial assistance. Additionally, 12% identified work as a need with an increased need for better hours, higher wages and a second job. Transportation (buy or repair a car) and food were mentioned more often than employment, with housing and clothing identified as a top need as well. Many of those interviewed mentioned more than one need, most often food and transportation.

ACCORD's ACCESS Center Food Pantry distributes personal care items, cleaning supplies, diapers and wipes, and when funding is available, provides bus tokens, clothing assistance and/or financial assistance to meet other basic household needs. The NYS Department of State Community Services Block Grant, the United Way of Cattaraugus and Allegany Counties and many year-round charitable donations make it possible for ACCORD to offer those essentials, in addition to food.

Those who are unable to register for the monthly distributions who need food are invited to visit the food pantry, which is generally open Monday- Friday. When visiting the food pantry, clients will meet with a Services Navigator who can provide services and referrals to assist families with their whole needs.

The ACCESS Center Food Pantry operates from 9:00 am to 3:00 pm on Monday, Tuesday, every other Wednesday, Thursday, and Friday. Please note it's closed for lunch from noon to 12:30 pm. Additionally, the pantry is closed on the 1st and 3rd Wednesdays of the month at 11:00 am due to staff involvement in Pop-up Pantries. Please try to select a pickup time that accommodates the quantity of boxes needed to avoid multiple pickup times for one driver or pickup person.

For the safety of our staff, volunteers, and participants, please do not arrive before your scheduled pickup time.
